## **Early Years Funding – 15 & 30 hours**

From September 2024, the Government introduced up to 30 hours of funded childcare per week for eligible children aged from +9 months.

A maximum of 38 weeks funding is available per year. The funding is to cover the cost of providing 15-30 hours of free, high quality, flexible childcare. It does not cover the additional hours, snacks and meals, consumables, activities and additional materials, trips, guest visits and other items that make up our enhanced nursery provision.

Parents must apply and provide an eligibility code to qualify for the 15-30 hours.

Please note:

- 15 hours funded places are **only** available for children attending a minimum of 3 x full days (8.00am-6.00pm) or 5 x mornings (8.00am-1.00pm)
- 30 hours funded places are **only** available for children attending a minimum of 5 x full days (8.00am-6.00pm)

Full fees will be payable for unfunded weeks provided during the year.

## **Use of Childcare Vouchers & Payment via Tax-Free Childcare**

Many families are eligible for Childcare Vouchers and Tax-Free Childcare.

There are strict Government guidelines over the use of childcare vouchers and payments via the Tax-Free Childcare scheme. Walton Nursery does accept both methods of payment but only for qualifying activities specified within the rules of the schemes.

These methods of payment are only accepted for the following eligible activities-

- Payment toward the wraparound care element of the fees (outside of the tuition day), including before nursery, after nursery, the early morning room and late room.
- Playscheme located on the nursery premises during nursery holidays.
- All fees for children in our Early Years setting.

Vouchers are not eligible to pay towards the following-

- Nursery Tuition Fees
- Nursery materials, uniform, stationery, kit, exams or clubs
- Residential or day trips that take place away from the nursery's premises

Please be aware that any overpayment of childcare vouchers or tax-free childcare cannot be refunded directly to parents due to HMRC rules. Where the overpayments cannot be carried against future childcare costs, these will be refunded directly to the childcare voucher provider or tax-free childcare account.

## **Basis of Charges**

- Nursery fees include 45.4 weeks of care as standard.
- Parents are required to provide all nappies, food and bottles until babies can eat nursery food. Dietary requirements and allergies will be accommodated where possible.
- Nursery meals are compulsory - for allergy reasons, packed lunches are not permitted.
- A non-refundable registration fee of £100 is payable by all new children.
- Fees are payable in advance either by monthly direct debit on the first day of the month, or termly on the first day of each term, or annually by 1st September each year.
- If payment of fees is not made on the due date, then interest of 10% will automatically be added monthly. Persistent late payments may result in exclusion.
- For those who enter mid-year, the fees are calculated according to the date of entry.
- 15-30 hours funding is applicable for children aged 0-2 years whose parents meet the eligibility criteria. For more information, please refer to <https://www.gov.uk/get-childcare>, Milton Keynes Council or contact the Bursar.
- Funded places are limited and conditions apply (see below):
  - 15 hours funded places are **only** available for children attending a minimum of 3 x full days (8.00am-6.00pm) or 5 x mornings (8.00am-1.00pm) for 35 or 38 weeks.
  - 30 hours funded places are **only** available for children attending a minimum of 5 x full days (8.00am-6.00pm) for 50 weeks.
- There is no reduction in fees if a child is absent due to illness, holiday and adverse weather conditions or for any other reason. In addition, the nursery will not be in breach of its obligations or otherwise be liable to you by reason of delay in performance or non-performance of its duties due to any event outside of its reasonable control. Such events include, without limitation: fire, war, acts of terrorism, strikes or other industrial action, infectious diseases and epidemics.
- Any request for changes to core hours must adhere to the notice period terms and conditions, one full month is required for the Nursery Department up to the age of 2. Extra hours will be made available as soon as practicable.
- Fees are subject to an increase at the start of each academic year.
- Parents who are not contactable by telephone, in case of a sick child or in an emergency, will be charged £20 after one hour and £20 for every subsequent hour, until they arrive.

## Fees 2026-2027 - Terms & Conditions

- Parents are liable for all costs, fees and charges including any costs reasonably incurred by the nursery in the recovery of unpaid nursery fees. The nursery reserves the right to exclude a pupil on 2 days' notice if fees are overdue for payment to the nursery, exclusion under these circumstances is not a disciplinary matter for the pupil.

### Notice Period

- In the Nursery Department, up to the age of 2, the notice period is one full month given by letter to the Nursery Manager. Failure to give the required notice will result in one month's fees being charged in lieu of notice.

### Introductory/Registration Fee Discount

- When a current or past family introduces a new family to the nursery, there is a one-off fees discount of £1,000 for the introducing family, providing the new child is full time. A pro-rata sum is given based on the hours on starting, if the new child is part-time. Only one family can make the introduction and therefore receive the discount. The discount is applied after the new child has completed a full term.
- The introducing family's name **must** appear on the Registration Form of the introduced child. If for any reason the new child leaves during the academic year, the discount will be limited to a third for each full term completed and reclaimed.
- The new family will have their registration fee of £100 waived.

### Sibling Discount

- Sibling discount will be applied after any other discounts, funding or reductions have been taken into account but before the annual payment discount.

### Other Discounts

- An annual payment discount of 5% is available if fees are paid in full by 1st September. The discount will be allowed on the element paid upfront if also paying monthly by childcare vouchers. Annual payment discount is applied after all other discounts, funding and reductions have been taken into account.

***These Terms and Conditions are deemed to supersede the Terms and Conditions for 2025/26. Your agreement to these Terms and Conditions is implied when your child starts the new nursery year from September 2026 onwards.***
